Function Rooms

The Members Lounge

This room is luxuriously appointed with leather couches in its own glass setting. A self contained bar, sound system and private bathroom facilities provides an excellent setting for exclusive functions and events for up to 120 people. A room hire fee applies for exclusive use of this room which includes security, staff and waiters if required; however, if you purchase a bar tab that exceeds \$500, the hire fee will be waived. All your guests will receive VIP/Priority Entry, with no door charge.

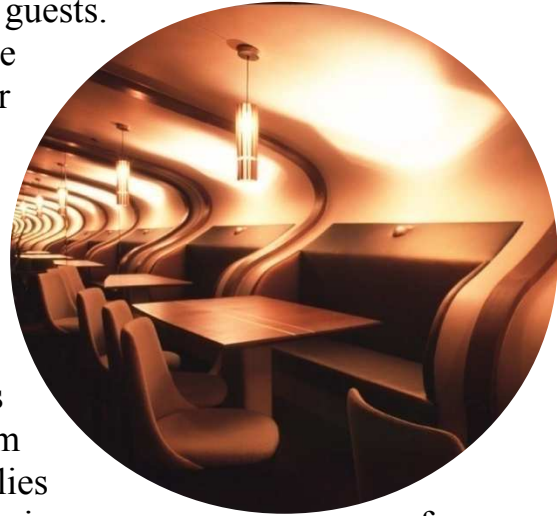
The Main Room

The Function Room

Located in the heart of the venue, this semi-private room provides an excellent VIP area for up to 65 guests.

Floor service ensures your drinks are on call, and a security guard ensures guest access only. A room hire fee applies for the exclusive use of this room which includes our security and drinks waiter, however, if you purchase a bar tab that exceeds \$300, the hire fee will be waived.

Entertainment

Bond Lounge Bar will provide background music at no extra charge or, if you wish, can arrange a DJ for your event from \$60 per hour. Your music preference would

you wish to provide your own entertainment (i.e. iPod, DJ) this may also be organised. Please advise which option you would prefer.

Multimedia Projectors

Projectors are available in the main room. These can be interlinked and run off a DVD, video or a computer (e.g. PowerPoint presentation) for no additional cost. For themed events, DVDs can be arranged to be screened at no additional charge.

Black Jack/Roulette Table plus Dealer

This is an additional feature to further enhance your event with a James Bond “high roller” theme. Hire of the tables are \$400.00 each for 4 hours.



Audio, PA & Speeches

The venue is fitted with a state of the art sound system suitable for most applications. A lectern with a cordless microphone and spot light is also available for announcements and speeches. The audio system is functional for background and dance music sound levels. There are no additional charges for these facilities.



Red Carpet

A red carpet can be provided to make your event that extra bit special.

Terms and Conditions

A non refundable deposit is required to secure your booking and each function booked at Bond lounge Bar is confirmed when only when a Booking Confirmation Receipt is signed and the deposit is paid. A refundable bond may be required for your function to indemnify the venue for any damage that may occur to the hired room but does not include normal wear and tear expected. The hirer of the room shall be financially responsible for any damages that may occur from their event and shall settle any damages as requested by management of the venue at the conclusion of the event or as agreed by management of Bond Lounge Bar. The final balance owing on your function must be paid on the night of the function.

Catering and Numbers are to be confirmed no less than 4 working days before your function. If we are not advised of your catering changes or numbers, the details above will be considered confirmed and will be charged accordingly. Bond Lounge Bar reserves the right to alter its menu without notice, and as such shall offer an alternative choice to the hirer. In the occurrence that a menu item is unavailable for any other reason, Bond Lounge Bar will either refund the prepaid item or offer an alternative.

Bond Lounge Bar reserves its rights to refuse entry to any person as it sees fit, and this booking does not guarantee the entry of any guests. All patrons entering the premises must be over 18 years of age, and photo id may be required. In compliance with state Liquor Licensing laws, no intoxicated person may enter the premises or remain on the premises and all guests are required to co-operate with the management of Bond at all times. If the management or security guards employed by Bond Lounge Bar determine a person unsuitable for entry, it is at their determination. Management will always reserve all rights of entry. Bond Lounge Bar cannot exceed its legal maximum number of patrons, and you are requested to have your guests arrive at a suitable time. In the event that the venue is at its capacity, any remaining guests may have to wait in a priority queue. The expected number of guests arriving for your event will be held open for a period of 2 hours from the commencement time of your event.

This event may be terminated at any time including during the event if the management of Bond determines the event to contravene safety of the venue and its patrons and non compliance of liquor licensing laws. This may include any patron or patrons behaving in an unacceptable manner for any reason whatsoever. In the situation where an event has been forfeited, all monies owing for bar accounts, catering and charges must be settled, and any bond or deposits held will be returned on full settlement of the event. There are no refunds for forfeited events.

Decorations are not permitted as the room might be used following your event. Photo boards are allowed, but cannot be affixed to the walls. Birthday cakes are permitted, however, disposable plates or napkins plates must be provided by the customer. No other food or drink is permitted onto the premises, unless authorised by management. Bond Lounge Bar does not accept responsibility for the damage or loss of any patron's property left on the premises prior to, during or after the event.

Prices in the function information package are correct at the time of printing and are subject to change. All prices are inclusive of GST.
